Chairperson's report

The TRAG was setup to influence the JSP/JLTP4 process with the objective of removing new proposed transport links that would route additional traffic through Tickenham Village.

The TRAG has had a busy year in firstly establishing the Group and then providing influence on the JSP plans. Key activities over this period include:

- 1) Inauguration meeting 15/2/19
- 2) Website and mail list setup
- 3) Regular Parish Council Newsletter and email communications
- 4) Media coverage in local press
- 5) Leaflet drop to all Tickenham residences
- 6) Traffic analysis covering historic and current volumes
- 7) Compilation of submission to JSP
- 8) Meetings with councillors, MP and NSC Technical Transport team
- 9) Presentation of objections to JLTP4 review at North Somerset Full Council meeting

Considerable support was provided by the residents of Tickenham, TPC and our ward councillor Nigel Ashton.

The JSP was withdrawn due to adverse comment from the Examiners. Subsequently, the TRAG have successfully campaigned to have the proposed routes from Nailsea and Clevedon (W4 and W5) removed from the JLTP.

Current Objectives

Objectives:

To lobby and influence the North Somerset Council and other appropriate Authorities to:

- 1) Modify and change the recommendation in the Joint Spatial Plan to route the existing and future vehicular traffic from the expanding Nailsea housing, through Tickenham and the B3130 to the M5 Junction 20.
- 2) Adopt the long term potential link from SW Nailsea directly to the M5 J20, until recently considered by Planners the sensible way forward.

These objectives are to be achieved by concerted Group action of meetings, petitions, press communications and any other legal means deemed necessary.

Agreed Objectives

Objectives:

To lobby and influence the North Somerset Council and other appropriate Authorities:

- 1) Review and assess the impact of transport proposals from NSC and related bodies on the village of Tickenham and provide representation at consultation and statutory forums.
- 2) Ensure that proposed plans (e.g. Local Plan, Transport Plan etc.) consider the wider transport needs, options and routes (e.g. key transport corridors between towns, cities, motorways and airports) when identifying transport proposals impacting Tickenham Village.

These objectives are to be achieved by concerted Group action of meetings, petitions, press communications and any other legal means deemed necessary.

Local Plan Scope

Scope of the North Somerset Plan

7. The plan area will be the administrative area of North Somerset Council and the plan period will be 2023-2038. This time period is consistent with the NPPF requirement for strategic policies within Local Plans to look ahead over a 15 year period from adoption. This time period may need to be reviewed dependent on progress.

8. The purpose of the Local Plan will be to deliver the number of homes needed for the district over the plan period including the necessary supporting facilities and infrastructure. There will also be a strong focus on tackling the climate change challenge, creating healthy places and addressing inequalities. The Local Plan will also review the policies and allocations in existing development plan documents (Core Strategy and Sites and Policies Plan parts 1 and 2, including waste and minerals).

9. The Local Plan will identify the spatial strategy, strategic policies and non-strategic policies. This will involve a review of the existing approach as set out in the current development plan, taking account of new priorities (such as addressing climate change), evidence and guidance (such as the housing requirement standard method) and with continuing effective co-operation on strategic planning matters.
